Update: MCTXSheriff Makes Arrest for Robbery That Occurred At The Woodlands Mall

After a Crime Stoppers tip led Montgomery County Sheriff's Office Detectives to the identity of a suspect, a warrant was secured for 28 year old Troy Damian Haynes. Haynes was located in Beaumont, and arrested for Aggravated Robbery in connection with the purse snatching that occurred at the Woodlands Mall on May 11, 2019. On the evening of June 26, 2019 Haynes was booked into the Montgomery County Jail where he is currently being held on a \$100,000 bond. Detectives are still actively investigating this incident, and additional charges may be sought.

The Montgomery County Sheriff's Office would like to thank our media partners and our community for all the information provided. Update: MCTX Sheriff Investigating Robbery at The Woodlands Mall

MCTX Sheriff Investigating Robbery at Woodlands Mall

The Montgomery County Sheriff's Office is attempting to locate the below pictured vehicle. The vehicle is described as an Early 1990's 4-door Ford dually, Green or Black in color with chrome side steps and a chrome metal tool box in the bed of the truck. This vehicle is a suspected getaway vehicle for a Robbery that occurred on May 11, 2019 at The Woodlands Mall, in The Woodlands, TX. The victim was walking to her car when an unknown black male approached her, and grabbed her purse. The suspect then fled in the vehicle pictured below toward I-45.
