A meeting is scheduled for Friday, November 17, 2023 at 4 p.m. This meeting will include regular business; however, at the end of the meeting the Board will canvass election results from the November 7, 2023 election. In November, the Board must canvass election results within the 3<sup>rd</sup> to 14<sup>th</sup> day after the election, making the canvass period from November 10-21, 2023. If canvassing numbers are not available for the November 17 meeting, a special meeting will be called for this purpose prior to the deadline to canvass the results. The new Board will be seated and elect officers at a consolidated November Board meeting on Wednesday, November 29 at 6 p.m.
