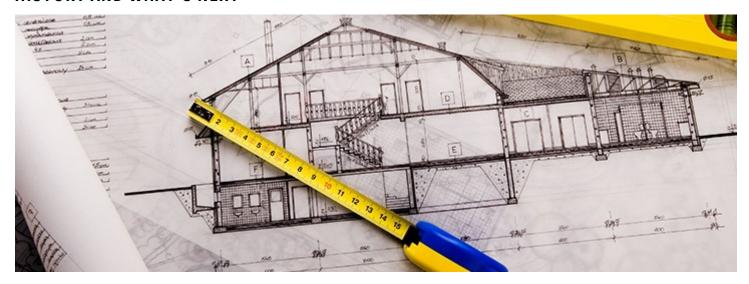

#### HISTORY AND WHAT'S NEXT



The City of Shenandoah and The Woodlands Township have worked together to streamline and simplify the permitting process in your neighborhood. This information packet provides details on the items that require permits, where to go, and what you need to do.

#### **HISTORY**

Dulcimer Woods, Avalon Oaks, and Cantwell Forest (Grogan's Forest Sections 5, 6, 7) were annexed into the City of Shenandoah in 2003. Because they were previously in The Woodlands, the original covenants still exist in these subdivisions. That means these three areas are subject to the City of Shenandoah's development codes and ordinances, and also The Woodlands covenant requirements. This information was provided to you when you purchased your house. Because of the dual requirements in these neighborhoods, residents often must go to the City of Shenandoah AND to The Woodlands to get the necessary permits or approvals for many home improvements.

Many of you have asked how you can avoid having to comply with The Woodlands covenants since you are now living in Shenandoah. Covenants, such as those in The Woodlands, can only be altered when they renew and require a 2/3 vote of all property owners within The Woodlands Association covenants.

#### **WHAT'S NEXT**

A new process for permitting/approval has been developed to make it more convenient and efficient for Shenandoah residents in these neighborhoods. Residents can now handle most permitting needs at Shenandoah city hall, instead of physically going to two places. Some items will still require permits from both Shenandoah and The Woodlands, and this packet provides those details.

#### THE NEW PROCESS



The chart on the following page shows items that require permitting from Shenandoah or The Woodlands, or both, but can now be handled in an easier and more convenient way. Some items require permits from Shenandoah, but there is no review required by The Woodlands.

Check marks in the Shenandoah column represent property improvements that can all be handled at city hall. We will process any documents and reports required by The Woodlands, and you will not have to visit their offices. If there are any issues or questions related to The Woodlands covenants, they may still contact you.

For more information on permitting requirements, visit us at shenandoahtx.us and click the Community Development button on the home page, then select "Residential Permits" on the left.

- Check marks in The Woodlands column represent property improvements that must be handled by The Woodlands. That means you must visit their offices to complete the necessary applications, but you do not have to come to city hall.
  - The Woodlands offices are located at 2801 Technology Forest Blvd in The Woodlands. You can also reach them at 281-210-3800. Visit them online at thewoodlandstownship-tx.gov and click Residents at the top and then select Covenants/Deed Restrictions under "Resident Resources." Many of the forms and other helpful information can be found there.
- 2. Exterior changes note on the chart that requirements for exterior changes are different for Shenandoah and The Woodlands. If you plan to change your exterior paint only, you must go to The Woodlands for approval and permitting. If you plan to change your siding only, you must come to Shenandoah for approval and permitting. If you plan to change your siding and paint it, you must come to both Shenandoah and to The Woodlands.

The following are included in this packet for your reference:

- The Woodlands Grogan's Forest Neighborhood Criteria Sections 5, 6, 7
- Joint Improvement Application for The Woodlands Township. You will need to complete this form, along with any applications required by Shenandoah when you visit city hall. Shenandoah will submit the joint application form to The Woodlands on your behalf to save you an extra trip.
